COMMISSIONER'S FOREWORD

I am pleased to present the Fiji Police Crime Statistics Annual Report 2020. The statistics presented in this report are based on official figures for police-recorded offences stipulated under the Crimes Act 2009 including offences under other Acts. The crime statistics garnered is essential as it sets a yardstick of our performance in terms of law enforcement and our aspirations to improve our services to all Fijians and visitors. Despite the changing criminal landscape and our responsibility to respond to the COVID-19 pandemic that shifted our policing response in 2020, the Fiji Police continued to stride to provide a healthy, safe, secure and conducive policing environment to our officers and our communities.

Maintaining the status quo during the pandemic was

fairly challenging as we have to align our strategies to address issues emanating from a pandemic that tested our capability and service delivery. However, I must commend our officers for the tremendous effort rendered throughout the crisis that presented unprecedented challenges and ensured the containment of the virus within a span of three months and the quick return to normalcy. Our ability to adapt during the crisis saw the alignment of two new offences under the Public Health Act and Public Order Act. These include *failure to comply with orders and malicious act*, two offences that fronted our daily registration of reports and one that required policy advice and guidance on how to safely and expeditiously accommodate the increasing number of offenders apprehended for breaching the COVID-19 protocols.

The past year's crime statistics recorded a decrease in serious crime by six percent and crime against children by one percent while detection rate accounted for 73 percent compared to 68 percent detection rate in 2019. On the contrary, overall crime increased by 20 percent which comprised 19 percent offences under the Public Health Act and Public Order Act that were COVID-19 related and the other 1 percent comprised offences of Assault Causing Bodily Harm. Illicit drugs registered a total of 1,412 cases which is a 16 percent increase compared to the previous year. The Fiji Police Force is committed in the fight against drugs and this is reflective of increased police effort through smart deployment of policing resources such as drones, inter agency collaboration, interception of drug trafficking at our borders, drug raids and uprooting of cultivated drugs in Fiji. In addition, the positive police-community partnership through the reinforcement of the Duavata Community Policing programs and the monitoring and controlling of illicit drugs, as well as exerted effort in combating burgeoning organized crime groups has successfully led to this achievement.

COMMISSIONER'S FOREWORD

The policing efforts complemented the government's war on drugs through the 5-year and 20-year National Development Plan (NDP) encouraging key government agencies to promote and ensure socio-economic stability and safeguarding of health, well-being and moral-ethic values with a view to fight against drug addiction and drug trafficking as a top priority for the Government. Additionally, crime against women also recorded an increase by seven percent.

Our continued collaboration and partnership with our stakeholders including government ministries, faith-based organisations, NGOs, civil society organisations, private organisations, individuals, communities and local policing counterparts, regional and international partners remain the cornerstone of crime prevention, investigations and prosecutions. Other enablers such as suitable legislation, technology and specialised units such as Forensics remain critical in our efforts to combat crime.

The Fiji Police Force applauds the Fijian government for its unwavering support towards providing the necessary budget, bolstered by leased automobiles and critical resources that added impetus to our day to day operations in serving our people.

We shall be more receptive, adaptable and responsive to the changes encroaching our policing front and I am confident that the men and women of the Fiji Police Force are prepared, equipped and motivated to continue their fine work serving the people of this nation and we remain committed to maintaining law and order for the security, stability and prosperity of all Fijians.

1.0 CRIME STATISTICS INTERPRETATION

Crime statistics analysis worldwide has remained a challenging yet critical element of decision-making to police officials. As the data collated varies and evolves around multiple factors, crafting crime data-sets is a cumbersome activity. Crimes reported on various time-lines (years) of previous occurrences are often reported in the current year. Subsequent arrests that roll-over to the following year also have a bearing on detection rates. Likewise, the number of counts per crime offence committed also has a large impact on the percentage(s) and/or number or units of crimes committed. The Fiji Police Force [FPF] continually face these dilemmas in maintaining and reconciling crime statistics.

The Fiji Police Crime Statistics Unit has for many years become the central data collation and analysis centre for the organization. There are however, other units within the agency, such as the Criminal Investigation Department (CID), Juvenile Bureau, and Operations Headquarters [Ops HQ] who either submit or manage data from their 'frontline' points of contact at police stations and community posts. Fiji Police crime data, are mostly classified or tagged to the definitions and classifications prescribed under the legislation such as the Crimes Act 2009, Minor Offences Act and other relative Acts. The cycle of data collation, compilations, analysis, dissemination and storage follows the structured practices with other policing and statistics agencies.

The credibility of the Fiji Police data, remains with the absolute integrity and accuracy of human led inputs to systems or database handling automated frameworks. Minimization of human 'influence' and 'contact' post-data entry, proves significant and appraises credibility of such processes. The FPF through the Statistics Unit strives for such an intervention, where publication such as the FPF Annual Statistics Report 2020, remains a credible document, worthy of public 'consumption', record and reference.

A structured approach as to how, Fiji Police handles and converts data into meaningful decision-making tools remains essential. A summary of definitions, criteria and guidelines to the compilation of the Fiji Police Data/ Statistics is mentioned hereunder.

1.1 CRIME STATISTICS COLLECTION

As stipulated in the Force Standing Orders [FSO], the Fiji Police Force Annual Statistics Report is derived under the following means:

- Receiving reports in Police Stations [35], Community Posts [78], and other units or intra/ inter-agencies which provide information and data; and
- Daily Crime Reports [DCR] - reports categorized as Crimes Registered (CR) at station level which is submitted daily from all 35 Police Stations in Fiji. These are daily occurrences of crime facts and figures that are fed from the stations to the divisional headquarters, and the Central Statistics Office at the Directorate of Planning, Police Headquarters.

1.2 OFFENCES CLASSIFICATION

The data compiled in this document is captured, translated, and classified under the Crimes Act 2009. There are over 250 different offences which are classified under a cluster of six (6) major categories.

Appended below are the six (6) major categories of criminal offences:

1. Offences against Lawful Authority;
2. Offences against Public Morality;
3. Offences against the Person;
4. Offences against the Property;
5. Other Offences against the Crimes Act; and
6. Offences against other Acts;

It should be noted that there are other offences (e.g. Failure to Comply with Orders, Malicious Act, etc.) not classified under the Crimes Act, 2009 which are also criminal in nature and have breached other Acts such as the Public Health Act, Public Order Act, etc.

1.3 REFERENCE PERIOD

The Crime Statistics Report is prepared annually for the period from 1st January to 31st December per the calendar year.

1.4 DEFINITION OF CRIME

Crime is an offence, classified as an act or omission forbidden by law for which the state enacts penalty punishable by law.

1.5 INVESTIGATION

Is the search for the truth in the interest of justice and in accordance with the specifications of the law.

1.6 REPORTED OFFENCES

Reported offences are offences which are reported to the Police and appropriate entries are entered in the Complaints Register. These are the data that gets analyzed and reflected in briefs and reports such as the '*Fiji Police Annual Crime Statistics Report*'. Any other perceived information or incident occurring in the communities that are underreported does not necessarily amount to a data.

1.7 DETECTED OFFENCES

All offences/crimes are deemed to be detected under the following circumstances:

- The offender has been arrested and/or produced before a court of law, or summoned and;
- The offender has been dealt with in accordance with the laws of the land, and authority vested to the Fiji Police Force such as cautioning juveniles.

1.8 DATA SOURCE

The Fiji Police Force Crime Statistics are compiled from the data received from the 35 Police Stations located within the five divisions namely: Central, Southern, Western, Eastern and Northern divisions.

1.9 MONITORING & EVALUATION [M & E]

The Fiji Police Force has a variety of Monitoring and Evaluation [M & E] methods in its criminal data process framework. First and foremost, the measure of performance is tagged to the institutional Annual Corporate Plan [ACP] through the Key Performance Indicator(s) [KPI].

These data form the core benchmark indicators of performance and productivity. The KPIs drive performances in personnel all throughout the year. In addition, initiated from the Planning Office, these data sets are monitored on a monthly and quarterly basis through the process of verification. The result of achievements, shortfalls and improvement of gap areas are handed to the Commissioner of Police, who then discloses these results in his quarterly address to all members of the Fiji Police. The same is also made public through a media release. Furthermore, daily monitoring of performance based on data takes place on the bi-weekly Skype briefs from the five divisions. Finally, the Statistics Unit has also embarked on issuing weekly bulletins in the '*Force Routine Order*', a form of newsletter in the Fiji Police Force.

1.10 DISCLAIMER

There is no intent to discriminate, vilify or malign certain segments of our society's victim(s) and/or offender(s) of crime on ethnic, gender, age, geographical or other classification based distribution. The publisher acknowledges that these factors are sensitive in nature, however, for analysis and better demonstration of data relative to Fiji, such is portrayed in this Annual Report.

1.11 PERCENTAGE CHANGE FORMULA

Please note the Percentage Change Formula:

$$\text{Percentage Change (\%)} = \left[\frac{\text{Current Value minus Previous Value}}{(\text{Previous Value}^*)} \right] \times \frac{100}{1}$$

* If the previous value = 0, the answer will be N/A, i.e., percentage change is not divisible by the number 0.

If the answer is a positive number then this is a percentage increase. If the answer is a negative number then this is a percentage decrease.

2.0 CLASSIFICATION OF CRIME REPORT & INTERPRETATION

The cases in this report are stipulated in the Crimes Act 2009 and are investigated by the Criminal Investigations Department (CID), Uniform Branch (UB), other Specialised Units and Task Forces. These data excludes those offences that are also criminal in nature but are investigated and prosecuted by other agencies such as FICAC, FIRCA etc. In such cases, these crimes are not reported to police and do not form part of our data-set, and may not be the ideal reflection of the true extent of crimes in Fiji.

1. CRIME REPORT (CR)

These are reports that are classified as offences under any Section of the Law and may contain strong elements of prima-facie (criminality based on sufficient evidence) to instigate investigation and prosecution.

2. NO CASE IN LAW (NCIL)

These reports are not classified as offence(s) under any Section of the Law. However, complainants are given credible advice and guidance to explore other causes of actions, like reconciliations, generating community cohesiveness, well-being, partnerships and harmony etc.

3. CIVIL CASES

These are reports which are civil in nature and can only be pursued by the complainant through civil processes. The police have no legal jurisdiction to investigate such complaints. These include seeking own legal advice through solicitors, and other legal frameworks, such as the Small Claims Tribunal etc.

4. TRIVIAL (Trivial IR)

These are reports which are trivial in nature and do not necessitate any formal investigation. Initial action(s) on attending these complaints are however undertaken in order to secure safety, security and harmony between the parties involved.

5. LOST & FOUND PROPERTY (L&FP)

These are reports in nature of Lost and Found property and are registered under the Lost and Found Register.

6. ACCIDENT REPORT (AR)

These are reports of road accidents which occur on public roads in Fiji. The figures under this category are captured under the Annual Traffic Statistics Report.

7. TRAFFIC BOOKING REPORT (TOR)

These are traffic booking cases for traffic infringements and Drunk & Drive cases.

8. UNIFORM BRANCH REPORT (UB)

Offences under the Crimes Act and Minor Offences Act are often investigated by the Uniform Branch personnel, and prosecuted summarily per charge and/or summon process.

9. POLICE ENQUIRY PAPER (PEP)

It is a docket (police enquiry paper [file]) prepared to determine whether a case is civil or criminal in nature after an investigation is conducted. As sufficient evidence (prima-facie) is ascertained, the file is then converted to a full Criminal Investigation Enquiry (CR).

10. REFERRAL TO OTHER STATIONS OR AGENCIES

These are reports that are referred to another police station for investigation since the offence was committed within that station or court boundary/jurisdiction respectively. In other cases, there may be a core government stakeholder who may have been the rightful agency to have attended to such complaints or calls to service(s). These may include: Health, Agriculture, Customs, Welfare, Municipalities, Roads Authority, Non- governmental agencies or other essential service providers etc.

3.0 CRIME HIGHLIGHTS - YEAR 2020

The year 2020 has a total of 20,364 crime cases that were recorded, and registered as active police investigation files. Comparatively, in 2019, 16,939 crime cases were recorded and registered. This demonstrates a 20% increase in crime cases when compared to 2019. When translated into raw figures, this shows an increase of 3,425 crime cases.

3.1 DETECTION

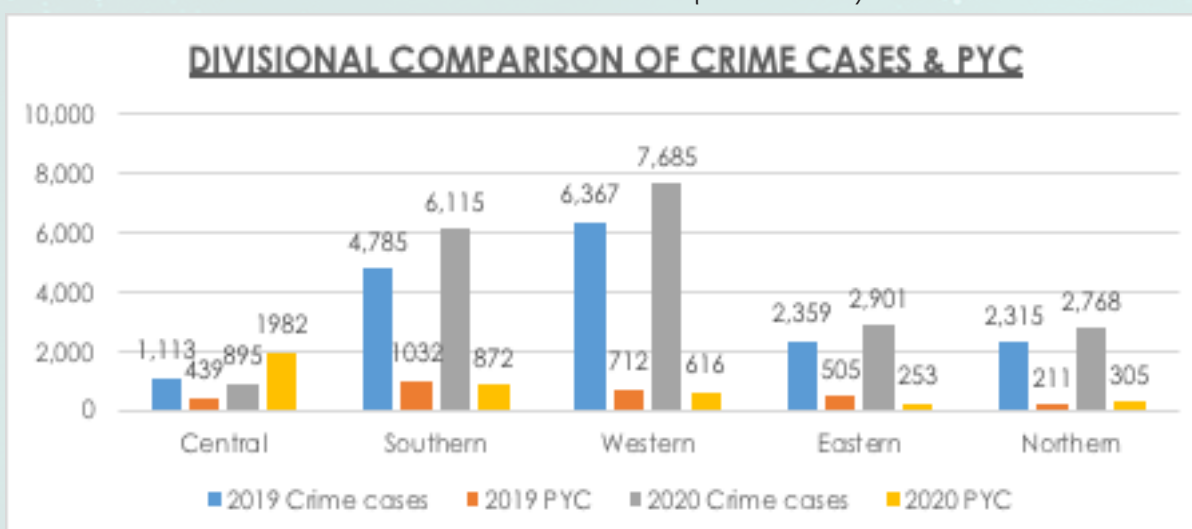
A 73% detection rate was recorded in 2020 when compared to 68% in 2019.

3.2 OFFENCE CATEGORY DISTRIBUTION 2020

- I. Offences against the Property (Prop) recorded 36.67% of the Total Offences,
- II. Offences against the Person (Per) recorded 28.00%,
- III. Other Offences against Crimes Act (CA) recorded 5.83%,
- IV. Offences against Public Morality (PM) recorded 3.93%,
- V. Offences against Lawful Authority (LA) recorded 2.63% and,
- VI. Offences against Other Acts recorded 22.94% of the overall offences(s).

3.3 DIVISIONAL DISTRIBUTION OF CRIME VS. PYC

Chart 1.0 Divisional Distribution of Crime vs. PYC (2019 & 2020)



The graph above shows the divisional distribution of crime cases vs. PYC for the years 2019 and 2020.

4.0 SERIOUS OFFENCES

Under the Fiji Police KPIs, there are eight offences which are categorised as 'Serious Offences'. These are: (1) Rape & Attempted Rape, (2) Defilement of children under 13 years of age, (3) Defilement of young person between 13 and 16 years of age, (4) Murder, (5) Aggravated Robbery, (6) Burglary, (7) Arson & Setting fire to crops and (8) Theft of Motor Vehicle.

1. RAPE & ATTEMPTED RAPE

Rape and Attempted Rape is an offence under the Offences against the Public Morality category. The year 2020 recorded 252 Rape & Attempted Rape cases whereas the year 2019 recorded 250 cases. Comparatively, this showed an increase of 1% (2 cases).

2. DEFILEMENT OF CHILDREN UNDER 13 YEARS OF AGE (DOCU 13)

The Defilement of Children under 13 years of age is an offence under 'Offences against the Public Morality' category. The year 2020, recorded nil cases whereas the year 2019 recorded 3 cases, a decrease of 100%.

3. DEFILEMENT OF YOUNG PERSON BETWEEN 13 AND 16 YEARS OF AGE (DOYPB 13-16)

The Defilement of young person between 13 and 16 years of age is an offence under 'Offences against the Public Morality' category. The year 2020, recorded 53 cases whereas the year 2019 recorded 78 cases. This showed a decrease of 32% (25 cases).

4. MURDER

Murder is an offence under 'Offences against the Person' category. The year 2020, recorded 20 cases whereas the year 2019 recorded 26 cases. This is a decrease of 23% (6 cases).

5. AGGRAVATED ROBBERY

Aggravated Robbery is an offence under 'Offences against the Property' category. The year 2020, recorded 386 aggravated robbery cases whereas the year 2019, recorded 446 cases. This is a decrease of 13% (60 cases).

6. BURGLARY

Burglary is an offence under 'Offences against the Property' category. A total of 1,838 burglary cases was recorded in 2020 while 1,837 cases was recorded in 2019, an increase by 1 case.

7. ARSON & SETTING FIRE TO CROPS

Arson & Setting Fire to Crops is an offence under 'Offences against the Property' category. While the year 2019 recorded 17 cases, the year 2020 recorded 11 cases. This is a decrease of 35% (6 cases).

8. THEFT OF MOTOR VEHICLE

Theft of Motor Vehicle is an offence under 'Offences against the Property' category. The year 2020, recorded 46 cases while the year 2019 recorded 68 cases. This is a decrease of 32% (22 cases).

5.0 SUMMARY

5.1 CRIME KEY PERFORMANCE INDICATORS

The table above shows the 5 years crime Key Performance Indicators. The FPF has made achievements in its Key Performance Indicators (KPIs) as follows: 4% decrease in serious crimes and 1% decrease in crime against children. However, there is a 20% increase in overall crime, a 7% increase in crime against women and a 16% increase in drugs offences.

The above table shows the Offence Category distribution for the years 2019 and 2020. Offences against the Property continue to be the most prevalent of the offences committed in 2020.

Overall, there was a 20% increase in the total number of crime cases recorded in 2020 when compared to the previous year.

Offences against the Person recorded an increase of 9%, Other Offences against Crimes Act recorded an increase of 4%, and Offences against Other Acts recorded an increase of 282% while the Offences against Lawful Authority recorded a decrease of 12%, Offences against Public Morality recorded a decrease of 4%, and Offences against the Property recorded a decrease of 5% when compared to the same period in 2019.

Table 4.0 shows the detection rate for 2020 was 73% and it has increased by 5% when compared to 2019, which recorded 68%. The offences with a detection rate of over 90% are as follows:

Bribery, Escaping from Lawful Custody, Others against Lawful Authority, Rape & Attempted Rape, Defilement of young person between 13 and 16 years of age, Incest, Sexual Assault, Abduction of a person under 18 years with the intent to have carnal knowledge, Murder, Attempted Murder, Manslaughter, Serious Assault, Conversion, Fraud & False Pretense, Receiving Stolen Property, Arson & Setting fire to crops, Forgery, Drugs, Failure to Comply with Orders and Malicious Act cases. There was a 73% of detected cases and 27% undetected cases during the year 2020, whilst a 68% for detected cases and 32% undetected cases were recorded for the year 2019.

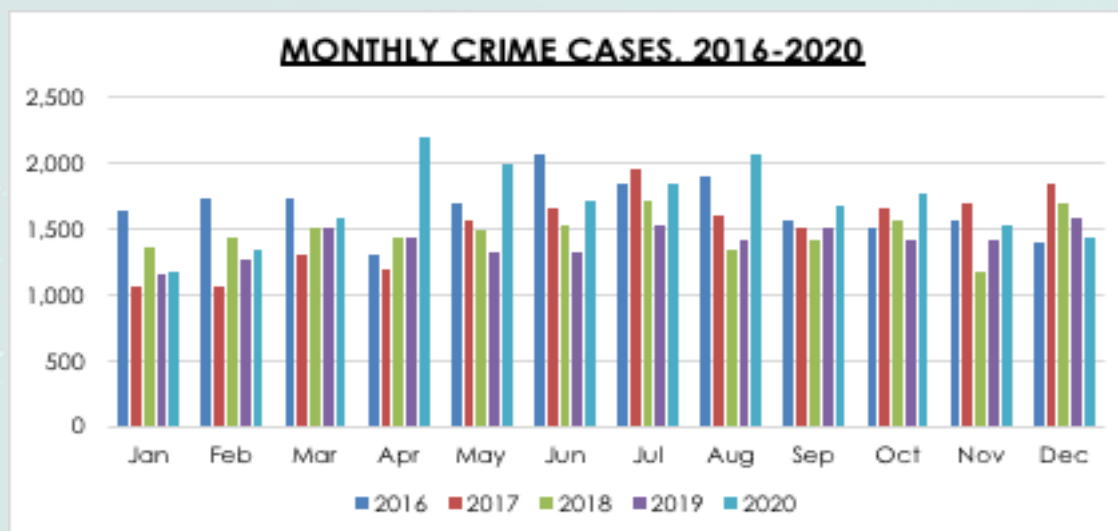

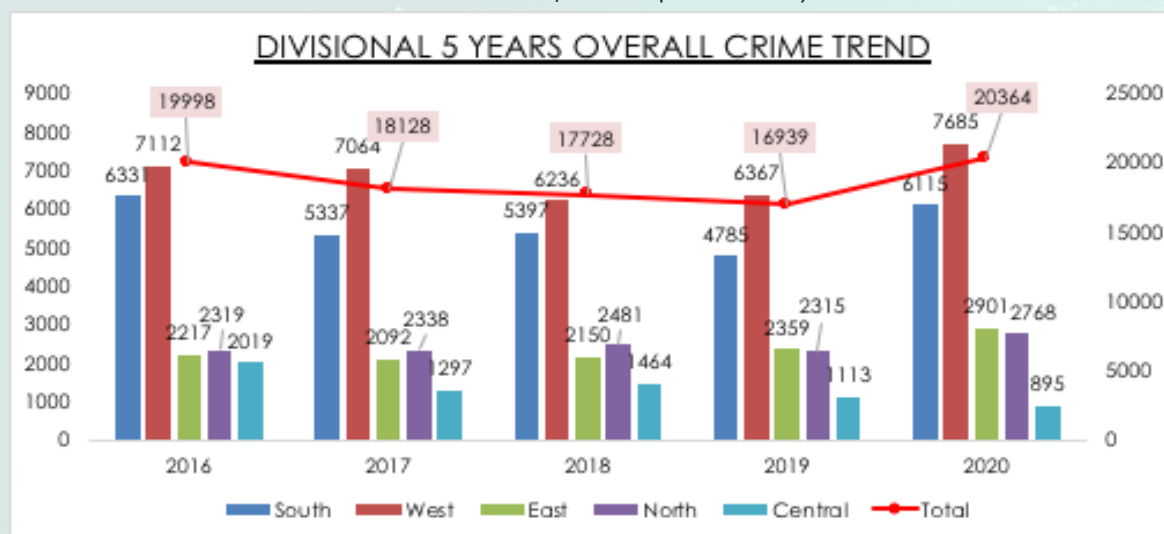
Table 7.0 shows the monthly comparison of crime cases for the year 2020. The months that recorded high crime cases are April and August. Other prevalent offences recorded during the year include: Rape & Attempted rape (44 cases) in September, Defilement of young person between 13 and 16 years of age (10 cases) in May, Sexual Assault (23 cases) in July, Murder (5 cases) in April and May, Assault causing actual bodily harm (371 cases) in August, Fraud & False Pretence (124 cases) in August, Aggravated robbery (52 cases) in August, Burglary (189 cases) in October and Theft (420 cases) in August.

6.0 DIVISIONAL CRIME TREND

This section gives a detail examination of crime in Fiji's five main policing divisions during the five-year period (2016-2020). The crime statistics kept by the Fiji Police Crime Statistics Office is compiled under three hierarchies: stations, divisions and national.

6.1 CRIME CASES DIVISIONAL COMPARISON

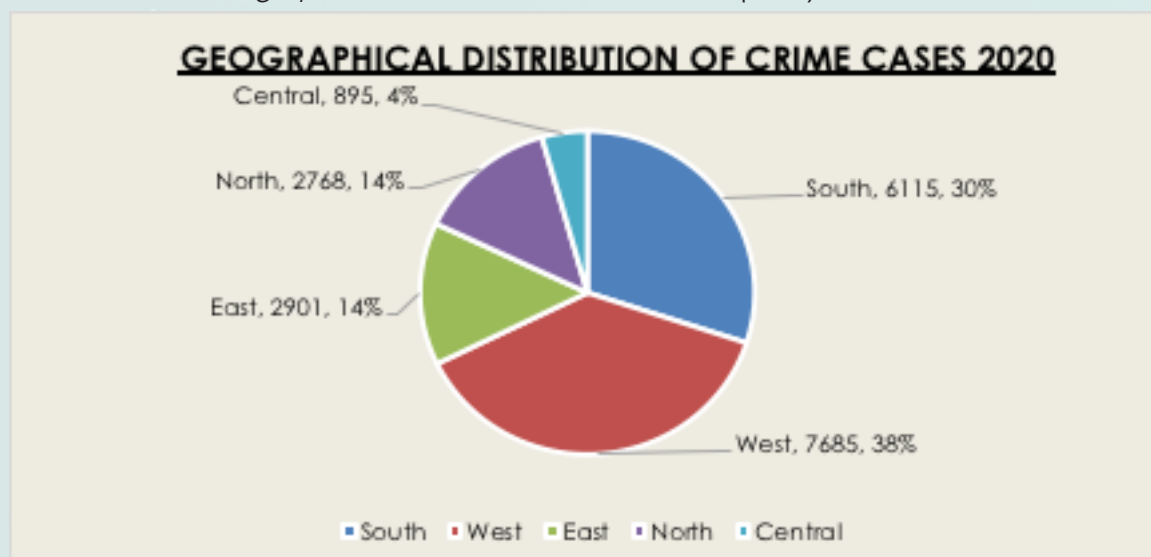
Chart 3.0 Crime Cases Divisional Comparison (2016 -2020)



The Combination chart 3.0 shows the divisional comparison of the criminal cases for the years 2016 to 2020. The crime trend shows an upward slope indicating an increase. In 2020, a total of 20,364 crime cases were reported, while 2019 had 16,939 crime cases; an increase of 20% (increase of 3,425 crime cases). The Southern division recorded an increase of 28%, Western division recorded an increase of 21%, Eastern division recorded an increase of 23%, and Northern division increased by 20% while the Central division recorded a decrease of 20%.

6.2 GEOGRAPHICAL DISTRIBUTION OF CRIME CASES

The above pie chart shows the geographical distribution of crime cases for the year 2020. From the overall 20,364 crime cases, the Western division recorded the highest with 7,685 cases (38%) followed by the Southern division with 6,115 cases (30%), the Eastern division with 2,901 cases (14%), Northern division with 2,768 cases (14%) and Central division with 895 cases (4%).

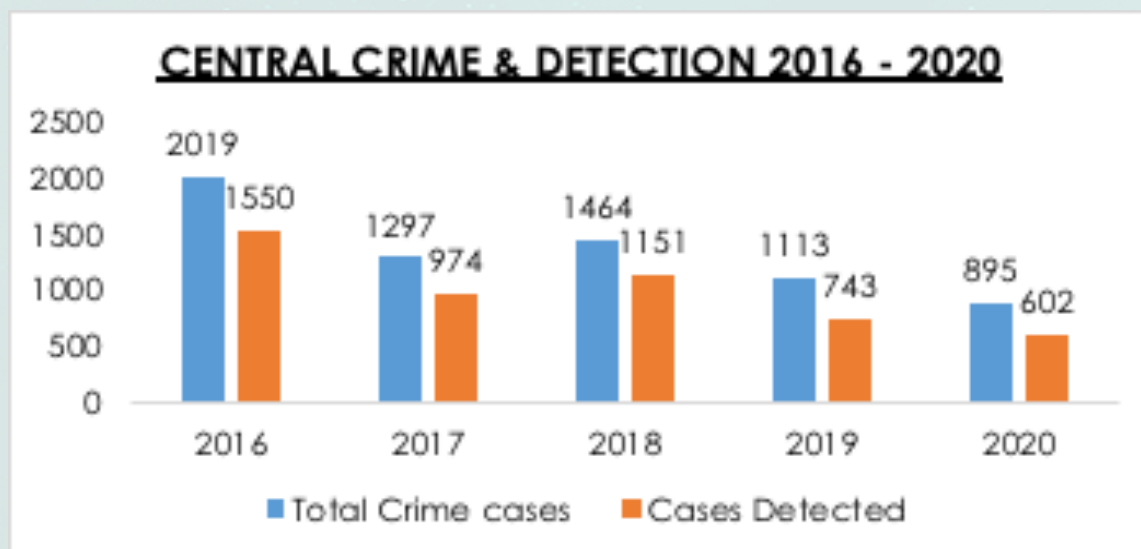

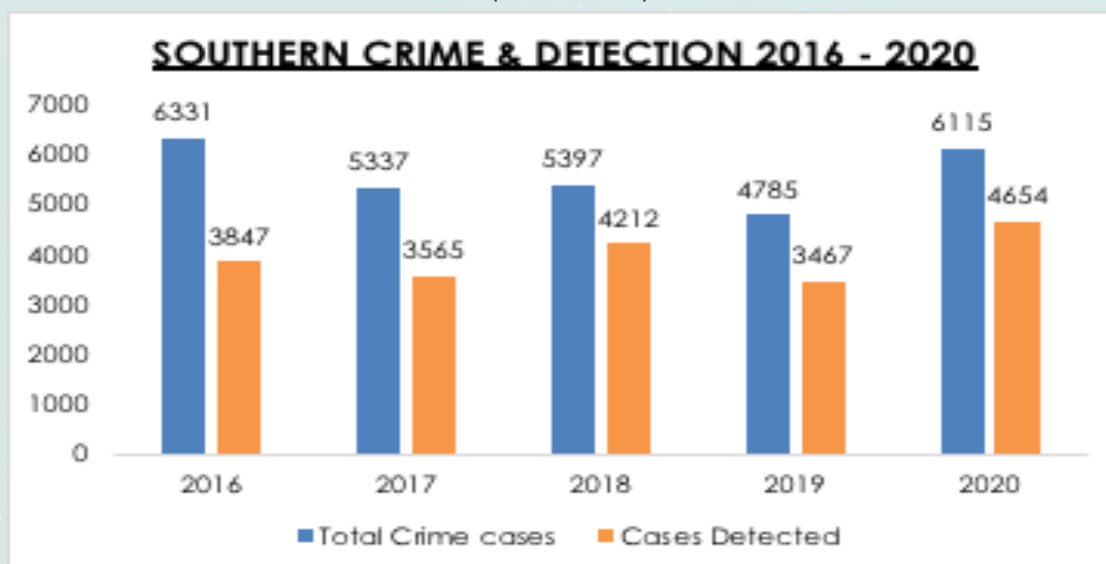

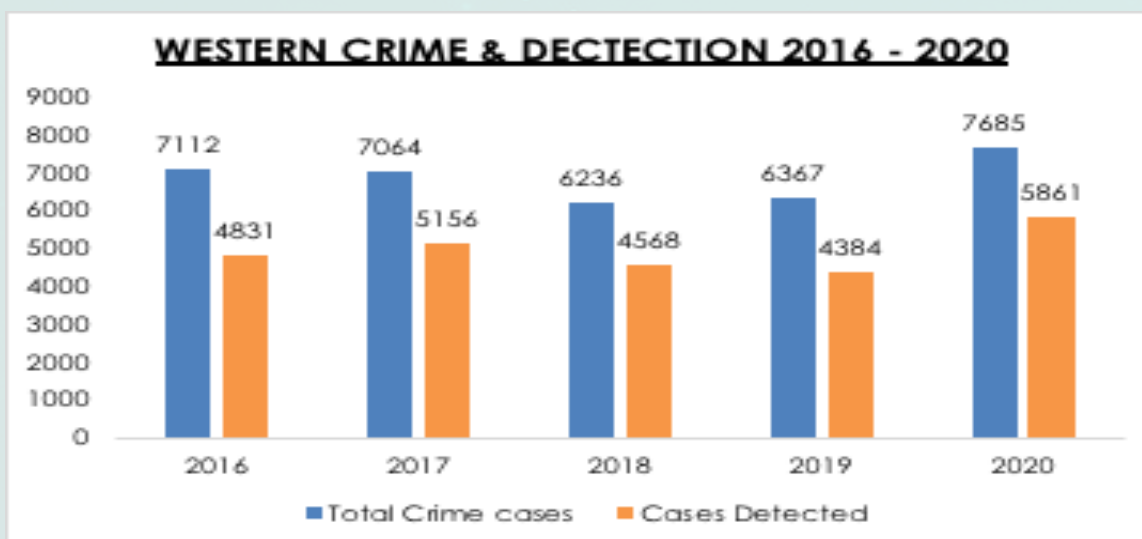

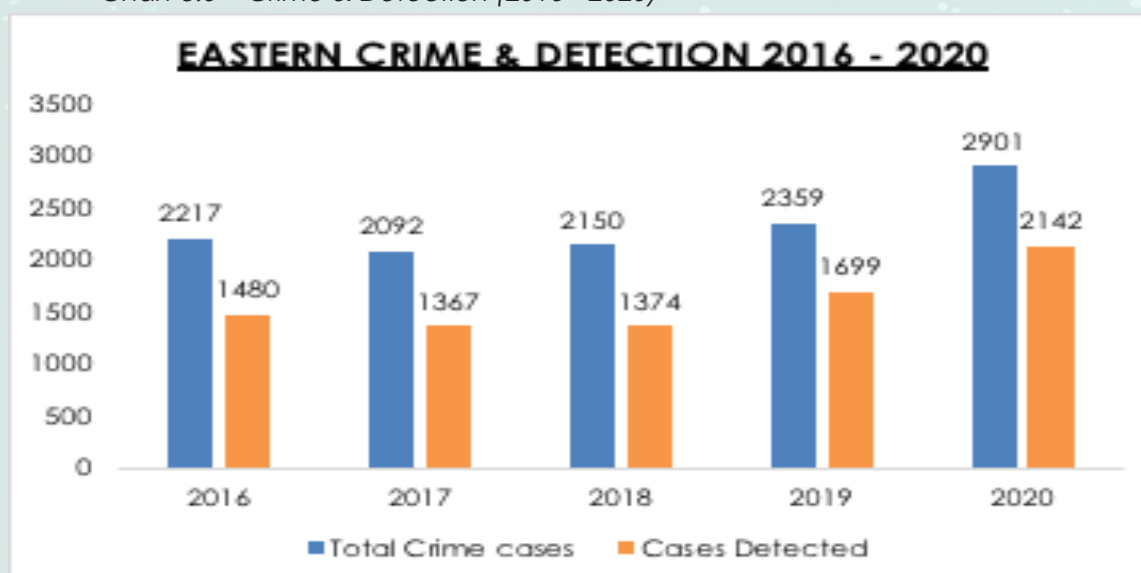

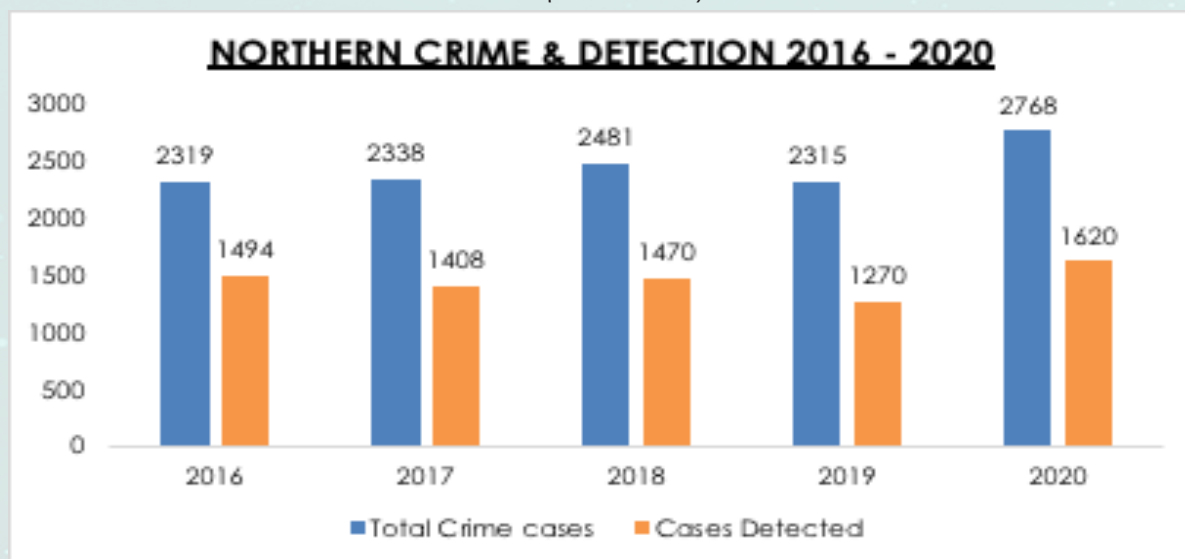

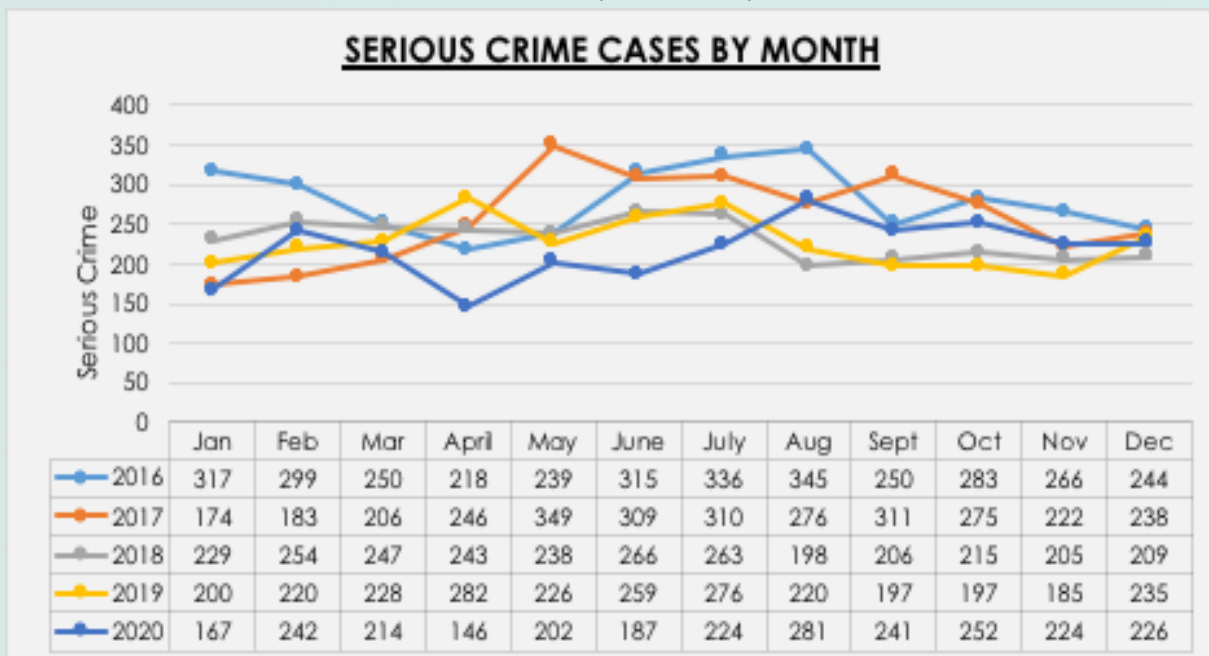

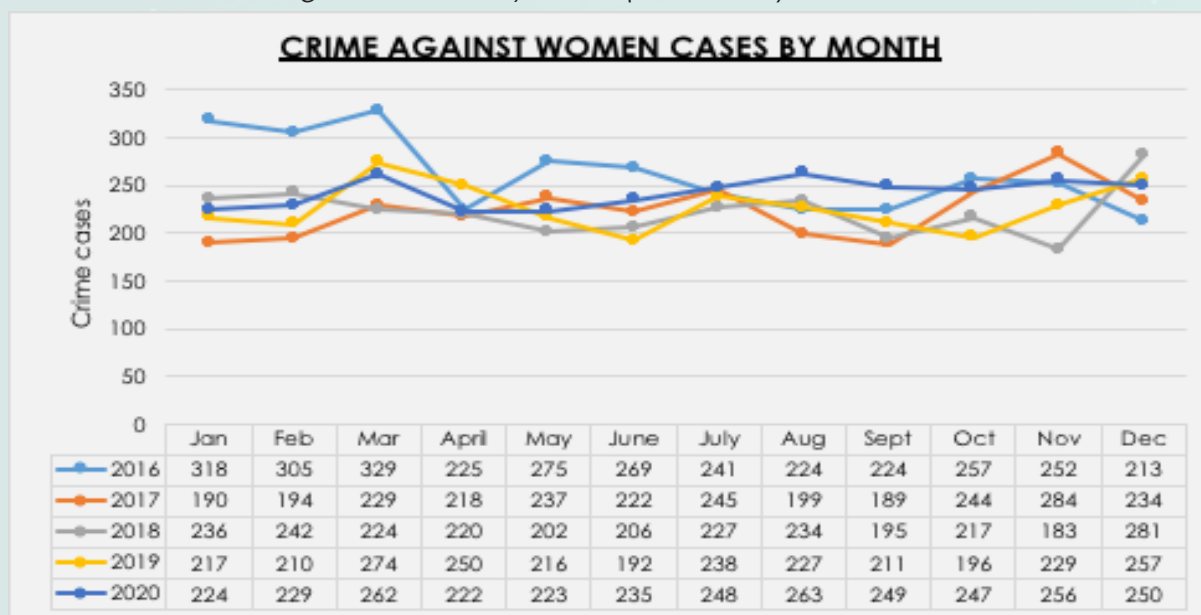

The table above shows the number of child sexual abuse cases in Fiji from 2016 to 2020. The table displays the age group (Less than & equal to 5 year olds, 6 to 12 year olds and 13 to 17 year olds) and the 17 types of sexual offences committed for the particular age group concerned.

The year 2020 reported a total of 538 cases of child sexual abuse. This is an increase of 2% when compared to the same period the previous year which recorded 530 cases. The age group that recorded the highest is the 13 to 17 year olds with 389 cases followed by 6 to 12 year olds with 122 cases and less than and equal to 5 year olds with 27 cases.

The 13 to 17 year old child victims of sexual abuse recorded an increase of 9% from the year 2019 to 2020.

Offences such as Rape, Indecent assault, Sexual assault, Defilement of young persons between 13 years and 16 years of age, and Abduction of person under 18 years of age with intent to have carnal knowledge continue to be the most prevalent form of sexual offences committed against children.

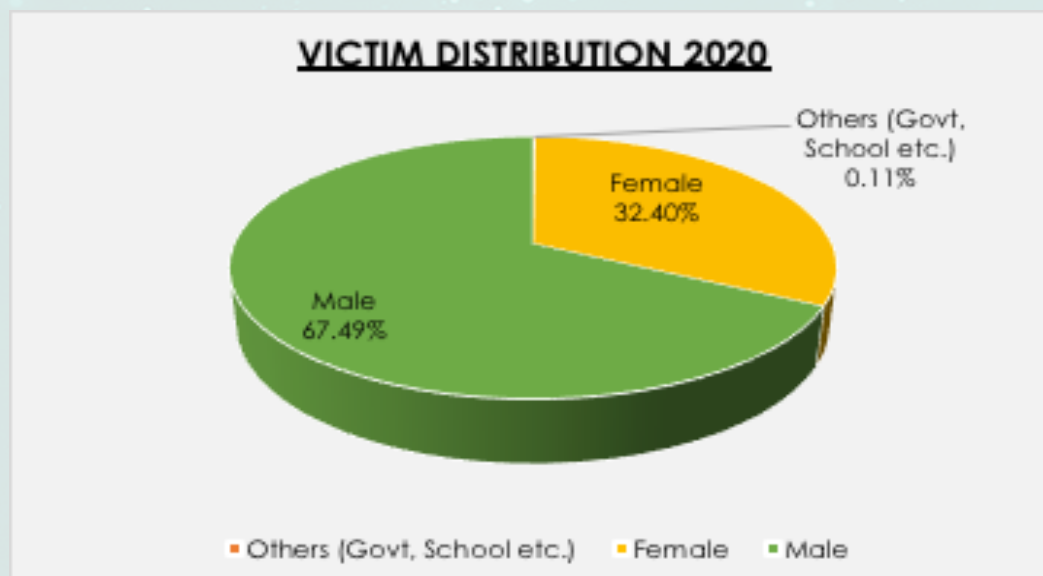
11.0 VICTIMS

Under Fiji Law, it shall be conclusively presumed that no child under the age of ten years can be guilty of any offence. Juvenile offenders are those below the ages of 18 years. Age refers to the offender's age during the time of apprehension by police.

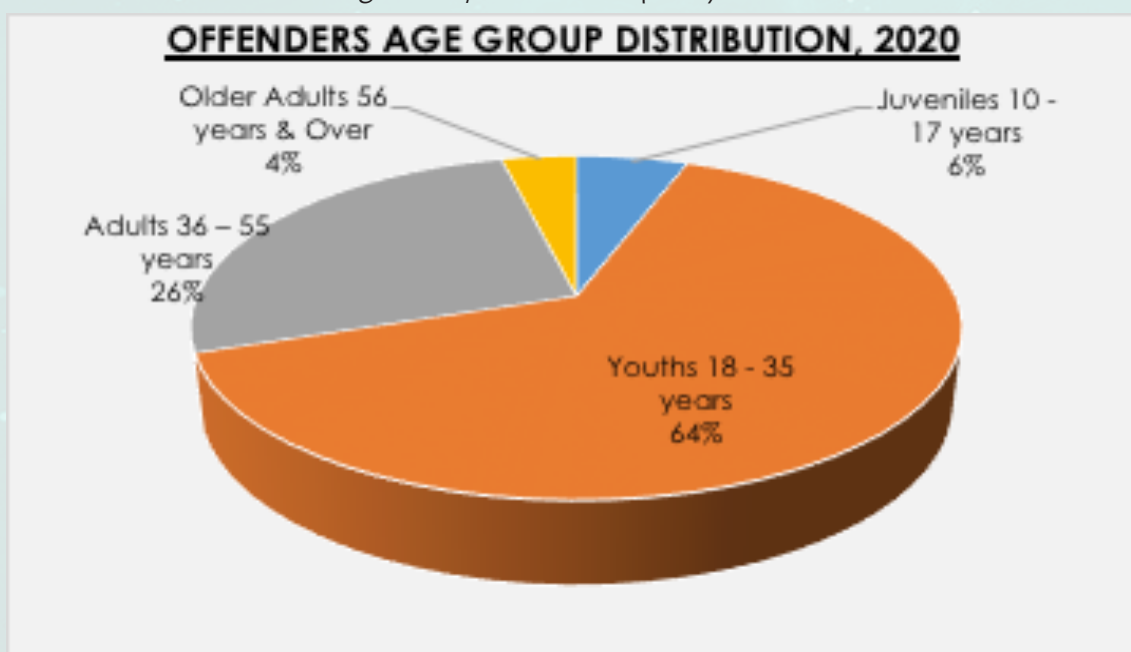

The victims were mostly i-Taukei (77%), followed by Fijian of Indian descent (15%) and others (8%). From the gender category, there were 81% male victims and 19% female victims. The Western division recorded the highest in 2020 with 18 drowning cases closely followed by Eastern with 16 cases, Southern with 9 cases, Northern with 8 cases and Central with 2 cases.
